Supporting proceedings in the US

Securities fraud actions

Providing English law advice including preparation of expert evidence and assisting in the preparation of briefs in multiple securities fraud litigation proceedings in California and New York, including before the Supreme Court, Appellate Division First Department.

English law advice

Advising on English law and other common law precedents for the purposes of presenting arguments under foreign law in California and New York including expert evidence on the assignment of claims, contractual interpretation, champerty and maintenance.

Negligence claims

Acting as insurers' representative on a range of heavyweight audit negligence claims around the world, arising out of large scale frauds and corporate collapses, including substantial litigation in several states.

Letters of Request

Proceedings outside the US

Enforcement proceedings

Acting for the state of Venezuela in relation to enforcement proceedings in England brought by Gold Reserve Inc. in connection with a \$700 million ICSID (Additional Facility) Award, with related proceedings in Washington D.C. and Paris.

Letters of Request

Acting for a US financial institution in conjunction with US Counsel to defend successfully proceedings in England seeking depositions and disclosure of documents in addition to an ongoing parallel discovery process in the US.

Pension fund recovery action
